RELEASE OF LIABILITY AGREEMENT

I am aware of the inherent risk associated with fishing and boating, including but not limited to the risk of collision with other boats and stationary objects in and around the river and bay, including rocks, reefs or piers or other vehicles and trailers at landing areas. I am familiar with other risks up to and including death by drowning associated with rough water, changing weather patterns, heavy winds and lightning storms. I expressly assume all risks associated with this tournament and hereby release Muskies Inc International, Titledown Chapter #4 of Muskies Inc. and the Green Bay Yacht Club and its members, sponsors, and tournament officials from all claims of negligence resulting from injury and/ or property damages incurred in connection with the tournament.
2. I know and freely assume all such risks, both known and unknown, even if arising from negligence of those persons released from liability below, and assume full responsibility for my participation; and
3. I will comply with all rules and regulations as stated. If I have any questions or observe any unusual or unnecessary hazards during my participation, I will immediately bring it to the attention of the nearest official, and
4. I, for myself, and on behalf of my heirs, assigns, personal representative and next of kin, hereby release indemnify and hold harmless the Muskies Inc.
