RELEASE OF LIABILITY AGREEMENT

I am familiar with other risks up to and including death by drowning associated with rough water, changing weather patterns, heavy winds and lightning storms. I expressly assume all risks associated with this tournament and hereby release Muskies Inc International, Titletown Chapter #4 of Muskies Inc. and the Green Bay Yacht Club and its members, sponsors, and tournament officials from all claims of negligence resulting from injury and/ or property damages incurred in connection with the tournament.
- 2. I know and freely assume all such risks, both known and unknown, even if arising from negligence of those persons released from liability below, and assume full responsibility for my participation; and
- 3. I will comply with all rules and regulations as stated. If I have any questions or observe any unusual or unnecessary hazards during my participation, I will immediately bring it to the attention of the nearest official, and
- 4. I, for myself, and on behalf of my heirs, assigns, personal representative and next of kin, herby release indemnify and hold harmless the Muskies Inc.
